INSTALLATION INSTRUCTIONS

NOTE: Always adhere to installation / usage instructions and warning. Improper use may result in injury, damage or hazardous spill.

- 1. Turn off dispenser and relieve line pressure.
- 2. Apply DEF compatable thread sealant to NPT threads of mating fitting.
- 3. Only connect to DEF compatible and 304 stainless steel fittings see page 2 for applicable seal configurations.
- 4. Install at the nozzle or other appropriate location for 1" BSPP Male x 1" NPT Female fittings.
- 5. Tighten firmly, approximately 15 20 lbf•ft / 20.3 27 N•m, but do not overtighten.
- 6. Pressurize system and visually check for leaks.

VERIFY SMOOTH ROTATION OF ALL SWIVEL JOINTS AFTER INSTALLATION. DO NOT OVERTIGHTEN

IF DRIVE OFF OCCURS

- Turn off dispenser and relieve line pressure.
- Inspect the entire dispensing system for damage.
- Pressurize system and visually check for leaks.
- Check for smooth rotation of all swivel joints.
- Measure gap at joint if a credit card fits in the gap (0.03 in / 0.76 mm) do not reinstall.
- Check for electrical conductivity.


Model 008510 Swivel thread type: 1 x 11 Male BSPP thread one end; 1 x 11 1/2 Female NPT other end.

Option 1

- Seal is in mating device port.
- Husky gasket or o-ring seal not required.


Option 2

- Seal formed by Husky o-ring.
- Husky gasket not required.



Option 3

- Seal formed by Husky gasket.
- Husky o-ring not required.
- Thread Husky gasket onto BSPP fitting plug. Do not press on.


